

## QUEENSLAND COUNTRY BANK

### 2024 'Brisbane Heat Ultimate Prize Pack' Terms and Conditions

Instructions on how to enter and prizes form part of these terms and conditions.

#### Section 1: General Information

1. **Promoter:** Queensland Country Bank Limited (ABN 77 087 651 027 AFSL/Australian Credit Licence 244 533), trading under the registered business name of 'Queensland Country' 333 Ross River Road, Aitkenvale QLD 4814. The Promoter can be contacted on 1800 075 078.
2. **Promotion Period:** The Promotion will run between 9.00am on Saturday 24 August 2024 to 11.59pm Wednesday 4 December 2024.
3. **Eligibility:** To be eligible to enter the draw, entrants must satisfy the following criteria:

  - (b) Be aged 18 years and over.
