

**QUEENSLAND COUNTRY BANK  
HIT YOUR BILLS FOR SIX COMPETITION**

**Terms and Conditions**

1. **Promoter:** Queensland Country Bank Limited (ABN 77 087 651 027), 333 Ross River Road, Aitkenvale QLD 4814. The Promoter can be contacted on 1800 075 078.
2. **Promotion Period:** The Promotion will commence at 9.00 AM on 24 October 2024 and will run until 11.59 PM on 16 January 2025. Entries must be received by the Promoter within this period to be eligible.
3. **Prize Details:** For every six hit by the Brisbane Heat across the Women's Big Bash League (WBBL) and Big Bash League (BBL) regular seasons (non-finals matches), Queensland Country Bank will contribute \$1,000, with each contribution adding to the Prize. The maximum Prize value is capped at \$100,000. Only one Prize will be made available and only one winner will be selected. No other prizes are offered, and entrants are not entitled to any additional rewards or compensation for entering the competition.
4. **Eligibility:** To be eligible to enter the draw, entrants must satisfy the following criteria:
  - a) Be a Queensland resident;
  - b) Be 18 years or older at the time of entry;
  - c) Register via the data capture form at [queenslandcountry.bank/hitforsix](https://queenslandcountry.bank/hitforsix) on the Queensland Country Bank website during the promotional period;
  - d) Entrants cannot be:
    - a director, employee or contractors of Brisbane Heat, Queensland Cricket, Cricket Australia, Cricket Australia Member Organisations, Queensland Country Bank and other agencies, firms or companies associated with the Promotion, and their immediate families are not eligible to claim prizes.
      - i. **Immediate family member** - includes your spouse or partner, your (or your spouse's) children, parents or other relatives, provided these live permanently with you;

The winner details will be published on the Queensland Country Bank website and social media channels for a minimum period of 28 days.

7. Prize delivery: The Prize will be delivered to the winner via electronic funds transfer to the winner's nominated bank account.
8. Re-draw details: A re-draw will be conducted by the Promoter at 5:00 PM on Monday 21 April 2025 at the address provided in Clause 1 if the prize remains unclaimed after 90 days. The Prize winner drawn under this Clause 8 will be determined by random draw and remains subject to entrants satisfying the eligibility criteria in Clause 4.
