Instructions on how to enter and prizes form part of these terms and conditions.

Section 1: General Information

- Promoter: Queensland Country Bank Limited (ABN 77 087 651 027 AFSL/Australian Credit Licence 244 533) trading under the registered business name of 'Queensland Country', 333 Ross River Road, Aitkenvale QLD 4814. The Promoter can be contacted on 1800 075 078.
- 2. <u>Promotion Period</u>: The Promotion will run from 9.00am on Tuesday, 2 July 2024 until 5.00pm on Wednesday, 31 July 2024.
- 3. <u>Eligibility</u>: To be eligible to enter the draw, entrants must satisfy the following criteria:
